Set-Up

Vendor set-up begins at 9:30 AM and must be completed by 11:30 AM. A designated area will be provided for loading and unloading, but vehicles (excluding food trucks) must be moved prior to 11:00 AM. A map with assigned spaces will be provided before the event. Vendors must set up in their designated space unless otherwise directed by a Woofstock organizer.

Requirements for Vendors & Food Trucks

ALL PAYMENTS must be received by the Humane Society of SC by **Monday, September 21, 2026.**

- Booths are available on a first-come, first-served basis — please reserve early to ensure available space.
- Woofstock organizers reserve the right to prohibit any product from being marketed at the event.
- This event will take place rain or shine. Prior to the event, you will be notified of an emergency contact number by 9:00 AM on the day of the event in case of extreme weather. No refunds will be given due to weather complications or cancellations within 30 days of the event.
- Vendors are responsible for staffing, setting up, and breaking down their booths.
- Vendors are responsible for bringing their own tent, table, chairs, and signage for their booth area. Tents outside of the marketplace must be weighted on all four corners.
- The Humane Society SC reserves the right to sell official Woofstock and Humane Society merchandise.
- Vendors must check in with event staff before setting up and must be present at their booth for the entirety of the event.
- Vendors are not permitted to set up before the designated set-up time without prior approval from the Humane Society.
- Vendors ARE REQUIRED TO have a valid Town of Lexington Business License
- All vendors are required to register for and remit hospitality tax payments to the Town of Lexington.
